What is HUD's final energy standards determination?

Adoption of Energy Efficiency Standards for New Construction of HUD- and USDA-Financed Housing - Final Determination On April 26, 2024, HUD published the final energy standards determination in the Federal Register.

When did HUD update its energy standards?

HUD last updated its energy standards in 2015 when it adopted the 2009 edition of the International Energy Conservation Code for single family/low rise buildings and the 2007 edition of ASHRAE 90.1 for multifamily buildings with 4 or more stories. Publication of this Notice places the agencies in full compliance with the statute.

Does the standard for energy consumption of buildings affect China's regulation system?

Unfortunately this voluntary standard has relatively little impact on China's regulation system and is often overlooked by authorities in government and industry. The national standard "Standard for energy consumption of buildings," carries more responsibility in regulating the actual energy consumption of commercial buildings in China.

How much energy should a commercial building use?

The standard prescribes two levels of energy use intensity (EUI in kWh/ (m² yr)) based on a national survey of thousands of commercial buildings located in major cities in China. The first level provides constraint EUIs that every building should not exceed.

What is the hierarchy of China's building energy standards system?

The hierarchy of China's building energy standards system is illustrated in Fig. 5. The top four standards target the efficiency of commercial buildings during the design phase, while the bottom two standards call for the monitoring of actual energy use during the operational phase.

What are the EUI requirements for energy efficient buildings?

The first level provides constraint EUIs that every building should not exceed. The second level provides threshold EUIs detailed specifically for energy efficient buildings.
