How much health insurance do employees have to pay in Chile?

This also includes the employer's mandatory contribution of 2.4%. These contributions are based on the employee's taxable income capped at 90 UF. In Chile, employees must pay 7% of their monthly paychecks for health insurance. Employers withhold these contributions from an employee's paycheck and must pay the insurance.

How are payroll contribution rates calculated in Chile?

In Chile, payroll contribution rates are calculated using Unidad de Fomento (UF), which is an inflation-indexed unit of account set and published by the Central Bank of Chile (BCCCh), with a new UF rate set each month. Payroll contribution caps are calculated based on 'no of UF*rate of UF'. For March 2025, the UF rate is 68,034 CLP.

Are remote employees taxable in Chile?

Many companies provide their remote employees with the equipment to create an ergonomic workstation, including dock stations, headsets, and a desk with a chair. Some employers offer ticket restaurante to their employees who work from the office, which is a non-taxable fringe benefit in Chile. The national social security funds the pension system.

Are self-employed employees in Chile?

In Chile, an independent contractor or a self-employed individual isn't entitled to the same statutory provisions as an employee. It's important to understand this delineation. With the exception of social security contributions, the majority of benefits stated in Chilean legislation only apply to full-time employees.

Are full-time employees entitled to benefits in Chile?

What is mandatory unemployment insurance in Chile?

Under the Chilean Labor Code, mandatory unemployment insurance is in place to support employees. The employee contributes 0.6% of their paycheck to fund unemployment insurance. This also includes the employer's mandatory contribution of 2.4%. These contributions are based on the employee's taxable income capped at 90 UF.
