Eligible projects can receive up to EUR30 million and be implemented at the transport and distribution level by the end of 2025.

This initiative aims to enhance the flexibility and stability of Portugal's power supply system amid its record-breaking solar electricity production. On July 31, the ministry announced the allocation of EUR99.75 million through a call for tenders to install energy storage projects totaling 500 MW.

How many projects were selected in Portugal's 2025 energy storage procurement?

A total of 43 projects were selected from 79 applications in Portugal's 2025 energy storage procurement. This included six projects from Spain's Iberdrola, which secured nearly EUR 20 million in public funding.
