Terna's thinking ...The date is set. The first of Italy's new energy storage capacity procurement auctions (MACSE) will take place on September 30,2025,Terna's president for grid development strategies,Francesco Del Pizzo,has confirmed.

How much storage capacity will Italy need by 2030?

Namely,according to the updated scenario developed by gas company Scam and power grid operator Terna,Italy will need 72 GWhof storage capacity by 2030 to meet the EU's "Fit for 55" package goals. Around 50 GWh of this capacity will be allocated to new utility-scale systems supported by MACSE to complement the growing penetration of renewables.
