How many new homes will Ireland deliver in 2025?

However, Ireland's unprecedented demand for new homes, driven by population growth and urbanisation, should galvanise opportunities in the residential sector to fulfil the government's ambition to deliver 50,500 housing units annually between 2025 and 2030.

How many projects qualified to participate in the RESS 3 auction?

Of the 33 projects that qualified to participate in the RESS 3 Auction as approved by the Minister, 31 projects submitted an Offer Price for their project via the RESS Auction Platform before the deadline of 12:00 on 15/09/23. EirGrid ran the auction on the afternoon of 15/09/23.

How will Superhomes 2030 impact Ireland?

If successful Superhomes 2030 will implement 10% of all retrofits in Ireland by 2030 and a total investment of EUR657m from 2020 to 2030, supporting 13,000 FTE jobs in the construction and retrofitting sector, and saving 167 kilotonnes of CO₂.

The RESS 3 Auction submission window for Offer Prices opened on 08/09/23 at 10:00 and closed on 15/09/23 at 12:00.
